Chief Harrell.

Thank you for meeting with me today and providing the report. I'm submitting an official complaint regarding Officer Dennis Mohan, Badge 2738, about his phone call to me on September 5, 2025 at 4:46 PM (CAD/Event #25-0010503).

Statements at issue (verbatim excerpts):

- 1. "the decree, it's not a court order. It's a decree."
- 2. "If there's even one message from you not involving the child, I'm going to charge you."
- 3. "You're showing a pattern of stalking... if you continue to do it, then it is against the law."
- 4. Direction to move exchanges to a police station despite no court order, and warning me not to go to the usual location.

Context:

- Domestic Relations confirmed today that the current governing order is the divorce decree until modified. My next hearing is on October 1. Interim relief is unlikely before then.
- I'm documenting peacefully, offering right-of-first-refusal (ROFR) in writing with reply deadlines, and not engaging in self-help.

Request for Guidance (so everyone is consistent):

- Treat a divorce decree as a court order; officers keep the peace but do not modify exchange terms unless a judge orders it or both parties agree in writing.
- Police-station exchanges are voluntary unless court-ordered; officers should not require them unilaterally.
- Telecommunications harassment is not triggered by any one non-child text; there must be purposeful/repeated harassment.
- Menacing by stalking requires a pattern; a single, peaceful observation is not a pattern.
- If there are safety concerns, document them and suggest the party seek a court order; avoid threats of arrest absent probable cause.
- When asked, provide name/badge and CAD/Event numbers so citizens can attach them to court filings.

Requests:

- 1. Open a professional-standards review and provide a complaint/intake number and the assigned investigator's name.
- 2. Preserve and review the call audio, CAD/dispatch notes, any report/supervisor notes, and today's lobby interaction.
- 3. Email your written guidance so I can follow it and show it to the Court if needed.

Request for investigation re potential falsification by reporting party





- c. <u>Right of First Refusal</u>: If either parent cannot exercise their companionship time, pursuant to the typical parenting schedule or the parenting schedule for holidays, vacations, and dates of importance, the other parent shall be offered the opportunity to have the time with the minor child, before the time is offered to family members, sitters, day care facilities, or other collaterals of the family.
- b. <u>Transportation</u>: Is it the general understanding of the parties that unless agreed otherwise, the parent whose parenting time is beginning, commonly referred to as the receiving parent, shall be responsible for arranging for transportation of the child at the start of their parenting time.

g. <u>Withholding Parenting Time</u>: Should either parent withhold parenting time from the other parent during the other parent's appointed parenting time without a prior
